Include the following with the bid form: Letter of intent from facility, equipment and hotel vendors

Include a layout of the facility showing equipment placement

Requirements for the Host Organization:

Facility must be large enough to accommodate 2 sets of equipment and large spectator area

Facility should have decorations to include plants, flowers or balloons

Award area should be decorated and able to accommodate 200 people

Coaches hospitality is required

AAI equipment is required

Electronic Scoring is required and must be approved by committee

Host Club Responsibilities

Contracts for facility, equipment, hotel, and scoring equipment

Order and pay for Team Banners as per Florida USAG

All expenses for Judges assigned to the competition including fees, transportation, hotel, meals

Organize and run event

Awards for Individual events and AA (will be ordered by State Chairman)

All State Meet hosts will reimburse Florida USAG for awards/shipping expenses for all State meets except the Level 8,9 & 10 Meet – the State will pay for the awards for level 8-10

Official State medals or trophies are required as indicated below

Level 2/3 – Award 100% event & AA with State medals

Level 4 & Prep Opt – Award 50% plus 1 on each event with medals plus 100% AA Trophies

Level 5/6, 8, 9, & 10 – Award 50% plus 1 on each event and AA with State medals

Florida State committee reserves the right to determine exact number and type of awards to be given at all State meets for events, AA and Team

Fee to USAG Florida: following the event the host club will pay Florida USAG the following fee PER ATHLETE

Level 2/3 & Level 4 \$8.00 per athlete

Level 5/6, PO & Level 7 \$7.00 per athlete

Level 8, 9 & 10 no fee due

Level 2/3 State Meet \$50.00 per athlete

Level 4, 5 & 6 State Meet \$60.00 per athlete

Level PO, 7, 8, 9, & 10 \$75.00 per athlete

\$50 Team fee all levels

Door Fees: Maximum that may be charged

Adults \$12.00 per day

Child(12 – 5yrs) \$ 7.00 per day 4 & under Free

Florida USAG Committee will do the following:

Select and assign all Judges to the competition

Order State medals (paid by Host Club)

Do draw and approve schedule for competition
